## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I: NAME

The name of the corporation shall be: FLAT RATE 2000, INCORPORATED

# ARTICLE II: PRINCIPAL OFFICE
