ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Safetouch of Treasure Coast, Inc., and the principal office and mailing address of this Corporation is 9600 Sunbeam Center Drive, Jacksonville, Florida 32257.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of these Articles of Incorporation. This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL

This Corporation is authorized to issue:


