The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be U.S. WEATHER CORP. The principal place of business of this corporation shall be 12800 University Blvd., Suite 600, Fort Myers, FL 33907.

ARTICLE II. NATURE OF BUSINESS
