The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is PEGGY J MASON M. S., D.M.D., PA.

# ARTICLE II - PURPOSE

This corporation is organized for the purpose of operating a dental practice in the state of Florida.
