ARTICLES OF INCORPORATION  
OF

The undersigned hereby organize a corporation for profit under the provisions of the Florida General Corporation Act, and pursuant to the following Articles of Incorporation:

ARTICLE I

Name and Address

The name of the corporation is:

ARTICLE 2

Duration

This corporation shall have perpetual existence, commencing upon filing.

ARTICLE 3

Purpose

This corporation is organized for the purpose of operating a wholesale sales company, which may also import and export products, and all other lawful business for which corporations may be organized under the Florida General Corporation Act.

ARTICLE 4

Capital Stock

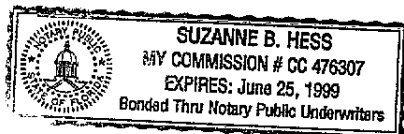


