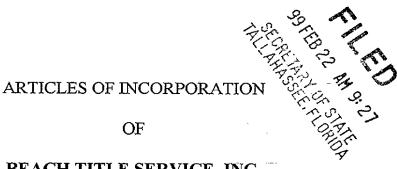

ARTICLE I

The name of this corporation is BEACH TITLE SERVICE, INC.

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

This corporation is authorized to issue 1000 shares of (\$1.00) par value common stock.
