ARTICLES OF INCORPORATION

OF

PERDIDO LIQUORS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Perdido Liquors, Inc. The principal place of business is 57 S. Coyle Street, Pensacola, Florida 32501.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue two classes of common stock. The Corporation is authorized to issue 10,000 shares of voting common stock with a par value of \$0.10 per share, which shall be known as "Class A Voting Common Shares." In addition, the Corporation is authorized to issue 10,000 shares of non-voting common stock with a par value of \$0.10 per share, which shall be known as "Class B Non-voting Common Shares."

ARTICLE V

REGISTERED OFFICE AND AGENT

ARTICLE VI

BOARD OF DIRECTORS

The initial Board of Directors of this corporation shall consist of two (2) members. The size of the board may be increased or decreased from time to time as prescribed in the bylaws or by applicable law, but never shall the board consist of less than one (1) member.

ARTICLE VII

INCORPORATORS

ARTICLE VIII

AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.
