The name of the corporation is I.A.M., INC.

ARTICLE TWO. PURPOSE

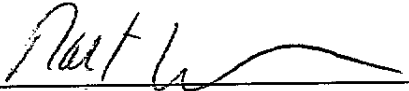

ARTICLE NINE. AMENDMENT

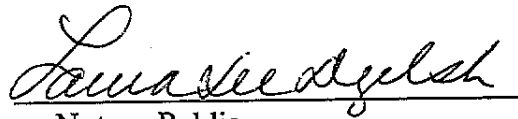

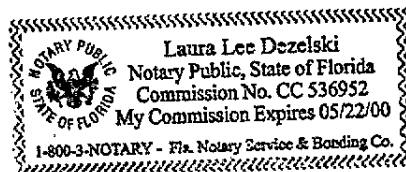

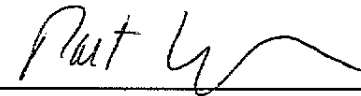
