ARTICLE I. NAME.

The name of the corporation shall be:

ARTICLE II. PRINCIPAL OFFICE AND REGISTERED AGENT.

Such interested director or directors may be counted in determining whether a quorum is present for the meeting at which such ratification or approval is given. If the vote of such interested director or directors, is, or was, necessary for the approval of such contract or transaction, then such contract or transaction shall, with disclosure of the director's or directors' interest, be submitted for the approval of or ratification by the stockholders.
