

ARTICLES OF INCORPORATION OF TRACY'S CATFISH AND SEAFOOD, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Tracy's Catfish and Seafood, Inc.
