The undersigned, as Incorporator of J & I HANDICRAFT TRADING COMPANY, adopted the below-detailed amendments to the Articles of Incorporation at a special meeting held on February 26, 1999. The Incorporator made such amendments prior to the issuance of any shares of stock in the above-named corporation. The adopted amendments to the Articles of Incorporation are as follows:

1. Article 1 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:


