ARTICLES OF INCORPORATION

OF

DIVE MARKETING INTERNATIONAL, INC.

The undersigned, being above the age of eighteen (18) years and competent to contract, and being a citizen and resident of the United States of America, for the purpose of organizing a forprofit corporation under applicable laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this Corporation shall be DIVE MARKETING INTERNATIONAL, INC. Place of business: P.O. Box 22878, Ft. Lauderdale, Florida 33335.

ARTICLE II

GENERAL PURPOSE; GENERAL POWERS

The primary purpose for which this Corporation is organized is to engage or transact in any and all lawful activities or business permitted under the laws of the United States and including all of the powers of a Florida corporation pursuant to the Florida Business Corporation Act, and nothing herein shall be construed as limiting or eliminating any such powers.

ARTICLE III

CAPITAL STOCK

Number of Shares Authorized: Par Value. This Corporation is authorized to issue Ten Thousand (10,000) shares of common stock, each having a par value of One Dollar (\$1.00) per share.

ARTICLE IV

INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be located at 1091 New Park View Place, West Palm Beach, Florida 33417, and the initial registered agent of this Corporation at that address shall be John Stewart. The Corporation may change its registered agent or the locations of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

ARTICLE VI

INDEMNIFICATION

The Corporation shall have all the powers and authority now or hereafter granted to permitted by law with respect to indemnification of directors, officers, employees and agents, and former directors, officers, employees and agents.

This Corporation shall have two (2) Directors initially and the number of <u>Directors</u> may be increased or diminished from time to time as provided in the By-Laws of this Corporation but shall never be less than one (1).
