#### ARTICLES OF INCORPORATION

## ARTICLE I - NAME AND ADDRESS

The name of this corporation is **ROYAL CANTURBURY CORPORATION** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 12550 Biscayne Boulevard, Suite 215, North Miami, Florida 33181.

#### <u>ARTICLE II - PURPOSE</u>
