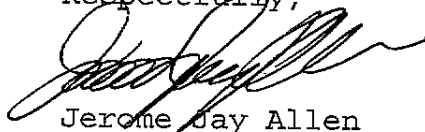
Upon receipt of your letter of February 11, 1999, received February 16, 1999, and phone call to your office, the name of VILLA SKYE, INC. was verbally approved.
