My name is Linda McCormick, President of McCormick's Cleaning Service, Inc. (tax ID # 65-0900278). My business has just completed its first year of operation.

The reason I am writing you is because I am in the process, as I go through my first year in business for myself, of learning the ins and outs of state and federal rules and regulations. Among these regulations is the annual filing of the UBR, which I did not know existed until I just came back from vacation and received a second notice from you, for an amount of \$550. Now, I am not up on all the laws, but as far as I know, I never received a first notice for what apparently was \$150 due May 1st! Could this be because this was my first year of business and it never went out?

I am immediately enclosing a check for \$150, and ask that you abate this \$400 penalty. I know that not being aware of all the laws is nobody's fault but mine, but I honestly do not remember receiving any first notice for this report. Now that I am aware of this UBR, I know to look for it in the coming years by May 1st.
