ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

ADVANCED INTERVENTIONAL CARDIOLOGY CONSULTANTS, INC.

ADVANCED INTERVENTIONAL CARDIOLOGY CONSULTANTS, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

1. The name of the Corporation is Advanced Interventional Cardiology Consultants, Inc. The date of filing of its original Articles of Incorporation with the Secretary of State was March 1, 1999.

2. Pursuant to and in accordance with Sections 607.1003 and 607.1006, Florida Statutes, these Articles of Amendment to Articles of Incorporation amend certain provisions of the Articles of Incorporation of the Corporation. These Articles of Amendment to Articles of Incorporation were authorized, approved, and ratified by the sole member of the Board of Directors and the sole Shareholder of the Corporation in accordance with Sections 607.0704 and 607.0821, respectively, of the Florida Business Corporation Act.

3. Article ONE of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following shall be inserted in lieu thereof:

"ARTICLE ONE"

NAME

The name of the corporation shall be : ADVANCED INTERVENTIONAL CARDIOLOGY CONSULTANTS, P.A.

4. Article THREE of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following shall be inserted in lieu thereof:

"ARTICLE THREE"

PURPOSE

1. The nature of the business to be conducted or promoted and the sole and specific purpose of the Corporation are to render professional medical services and any lawful act or activity allowed under and in accordance with the Florida Statutes.

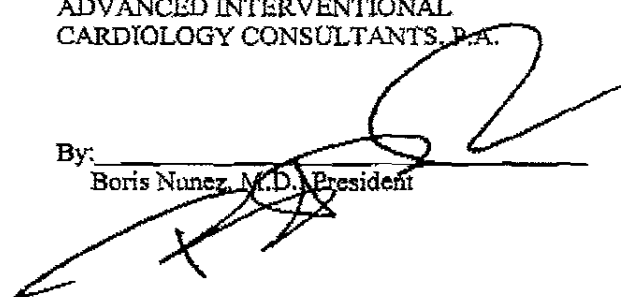
