ARTICLES OF INCORPORATION
OF
TALENT FIVE, INC.

ARTICLE I- NAME

The Name of this Corporation is TALENT FIVE, INC.

ARTICLE II- DURATION

This corporation shall have a perpetual existence commencing on the Date of Filing.

ARTICLE III- PURPOSE

ARTICLE X- INCORPORATOR

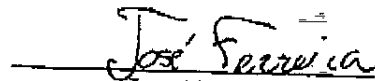

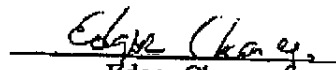
ARTICLE XI- AMENDMENT
