ARTICLES OF INCORPORATION

of

FEC - FASHION ENGINEERING CORPORATION

ARTICLE I - Name and Address

The Name of this corporation is FEC - FASHION ENGINEERING CORPORATION, (hereafter referred to as the Corporation). The Corporation's principal address is One Financial Plaza, Suite 2202, Ft. Lauderdale, Florida 33394.

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on the date these articles of incorporation are filed with the Florida Department of State.

ARTICLE III - Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE XII - Registered Agent






