THESE ARTICLES OF INCORPORATION are hereby adopted by undersigned incorporator(s) of this corporation for pecuniary profit under the Florida Business Corporation Act.

ARTICLE I. NAME AND LOCATION OF AGENT AND OFFICES

SECTION 1.1 NAME:

The name of the corporation shall be TEAM WORK OPTICAL CO. OF AMERICA, INC.

SECTION 1.2 PRINCIPAL OFFICE or MAILING ADDRESS:
