
We received for the first time, as an attachment to a letter, on August 3rd the 2000 Florida Corporation Annual Report Form. This July 17th letter stated that "the filling fee for the form is \$150.00 and if the form is not filled before September 13th, 2000 the corporation will be automatically dissolved and the costs to reinstate the corporation will increase to approximately \$600.00". The form also stated in big white on red background "FILE NOW! Report Due by September 13, 2000"

Knowing the importance of this documents and going out of town the following week I promptly on August 4th sent you the completed form along with our check # 2019 in the amount of \$150 in full payment for this annual report.

Earlier today I received subject-unsigned letter from Katherine Harris, Secretary of State, stating that the "report has not been filed" and that we need to submit a \$400 late fee. I called and talked to your office and was informed that the report need to filed by May 31st even though you don't get the forms to 60 days after due date.
