ARTICLES OF INCORPORATION

OF

FOSTER MOTOR COMPANY TRANSPORT, INC.

ARTICLE I. NAME

The name of this corporation is Foster Motor Company Transport, Inc.

ARTICLE II. CORPORATE DURATION

The duration of the corporation is perpetual.
