**ARTICLES OF INCORPORATION
OF
TEAM DISTRIBUTION, INC.**

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Team Distribution, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on March 1, 1999 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

ARTICLE V - REGISTERED AGENT

ARTICLE VI - INCORPORATOR

ARTICLE VII - BOARD OF DIRECTORS

The number of directors may be increased or decreased from time to time thereafter according to the bylaws of the corporation but shall never be less than one. ARTICLE VIII - SHAREHOLDER PROPERTY

Private property of the shareholders shall not be subject to the payment of the corporation's debts. The corporation shall have a first lien on the shares of its shareholders and upon the dividends due them for any indebtedness of the shareholders to the corporation.

ARTICLE IX - AMENDMENTS TO ARTICLES

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
