**ARTICLES OF INCORPORATION
of

The undersigned person(s), acting as incorporator(s) of a corporation organized under the laws of Florida, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I
CORPORATE NAME**

The name of this corporation is davidvogt, inc.. The principal office and/or mailing address will be 340 Fourth Street South, Safety Harbor, FL 34695.

**ARTICLE II
SHARES**

The total number of shares which the corporation shall have authority to issue is 100 shares of no par value stock.

After the initial board of directors, the board shall consist of such number of directors as shall be determined by the shareholders from time to time at each annual meeting at which directors are to be elected.


ARTICLE VI LIABILITY OF DIRECTORS


