Subject: Request Waiver of Fee for Corporation Reinstatement



To Whom It May Concern:

I, Angel J. Velazquez, President of Integrity Funding Mortgage Corporation (a Florida Corporation filed on February 25, 1999), am requesting a waiver of the application fee for Corporate Reinstatement.

I am an Air Force Reservist and have been on continuous military active duty since August of 1999. In November of 1999, I went overseas on military assignment returning in April 2000. Following that assignment I was sent to Texas, Jacksonville, FL, Tampa, FL, and Washington, D.C. We placed a forwarding address with the U.S. Postal Service with each change of address, but they did not forward official State of Florida mail. Therefore we did not receive the papers in order to take the appropriate measures to renew. Though I am still under military service at this time, I have placed a new address on the Corporate Reinstatement Form (Registered Agent) that will allow us to receive official mail with no further problems.
