The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I – NAME**

The name of this Corporation is S.D.A. PRODUCTIONS, INC.

**ARTICLE II – PRINCIPAL OFFICE**

The street address of the initial principal office and mailing address of this Corporation shall be: 8034 Wiles Road, Suite 141, Coral Springs, Florida 33067.

**ARTICLE III – PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV – CAPITAL STOCK**
