We recently submitted Articles of Incorporation which were rejected because the name selected was too similar to that of an existing Corporation.

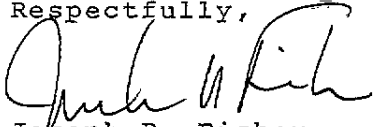

ARTICLE I

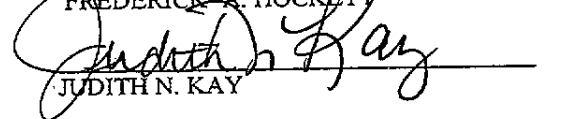

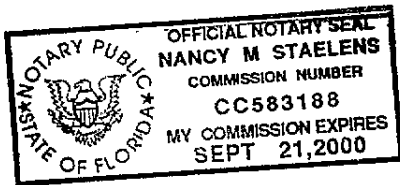

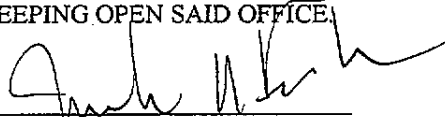
