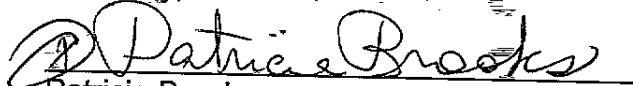

ARTICLE IV

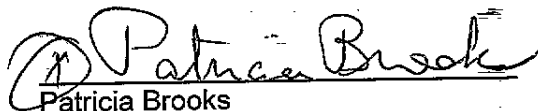
