
**ARTICLE IX**

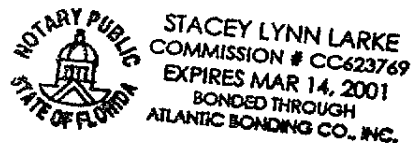
