ARTICLES OF INCORPORATION OF PARIS MANAGEMENT, INC.

The undersigned, both being a natural person and at least eighteen (18) years of age, for the purpose of associating himself as incorporators and organizing a corporation for conducting the business and promoting the purposes hereinafter stated, under the provisions of and subject to the requirements of the Florida Business Corporations Act and Acts amendatory thereof and supplemental thereto, hereby certifies that:

FIRST: The name of the corporation is PARIS MANAGEMENT, INC. (hereinafter referred to as "the Corporation").

SECOND: The Corporation shall have perpetual existence.

THIRD: The nature of the business and the purpose to be conducted and promoted by the Corporation are to engage in any lawful act or activity for which Corporations may be organized under the Florida Business Corporations Act. TENTH: The effective time of the Articles of Incorporation of the Corporation, and the time when the existence of the Corporation shall commence, shall be when the Articles of Incorporation are filed with the Secretary of State.
