<u>ARTICLE I</u>

NAME AND ADDRESS

The name of this corporation is PRESCRIPTIVE H.Rx. SOLUTIONS, INC. and its principal address is 1597 Weybridge Circle, Naples, Florida 34110.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

PURPOSE

for the corporation or on the books and records of the corporation, or followed what he believed to be sound accounting and business practice.

<u>AMENDMENT</u>

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them by a two-thirds vote of the shareholders.
