- FIRST:** The name of the corporation is Digital Dominion Corporation.
- SECOND:** The following amendments to the Articles of Incorporation were adopted:

- A. "Article IV shall be amended in its entirety as follows:

ARTICLE IV

Authorized Shares


- Number:** The aggregate number of shares that the corporation shall have the authority to issue is 30,000,000 shares of Class A Common Stock.
- Voting Rights** Each share of Class A Common Stock will entitle the holder to one (1) vote per share.
