ARTICLES OF INCORPORATION**OF****T.A. Selvig, Inc.****ARTICLE III*****DURATION:***

The Corporation shall have perpetual existence.

ARTICLE IV***PURPOSE:***

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be now or hereafter organized under the laws of the State of Florida.

ARTICLE V***CAPITAL STOCK:***

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than seventy-five (75) persons. The total number of shares authorized shall be one thousand (1000) with a par value of \$1.00.
