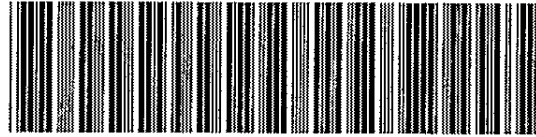

1. The name of the corporation is Mediterra Realty, Inc.
2. Article 1 of the Articles of Incorporation of the corporation is hereby amended to read as follows:

"Name

The name of the corporation shall be Bonita Bay Group Realty at Mediterra, Inc."
