CORPORATE NAME

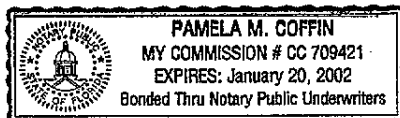


