# ARTICLES OF INCORPORATION of BENJI WEB PRODUCTIONS, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

#### ARTICLE I.

#### NAME

The name of this corporation shall be Benji Web Productions, Inc.

### ARTICLE II. PRINCIPLE OFFICE

## ARTICLE III. DURATION
