First: The name of the corporation is Stephen L. Franco, Corporation.


Second: Its registered office in the State of Florida is to be located at 2329 Alderman Oaks Drive, Jacksonville, FL 32224, Duval County.

Fourth: The registered agent in charge thereof is Stephen L. Franco residing at 2329 Alderman Oaks Drive, Jacksonville, FL 32224.


