

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME AND ADDRESS

The name of the corporation is MARINE FORCE, INC. and its initial post office address and its principal office for conducting business is: 3341 Timberwood Circle, Naples, FL 34105.

ARTICLE II - DURATION

This corporation shall have perpetual existence, effective upon the filing of these Articles with the Florida Department of State.
