ARTICLES OF INCORPORATION

OF

C.N.C. PARTNERS, INC.

San To The undersigned incorporator hereby executes and acknowledges these Article Incorporation for the purpose of forming a corporation for profit under and by virtue of the laws of the State of Florida as contained in the Florida Business Corporation Act, Chapter 607, Florida Statutes.

<u>ARTICLE I - NAME</u>

The name of this corporation shall be C. N. C. PARTNERS, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation shall be 18117 Regents Square Drive, Tampa, Florida, 33647. The mailing address of this corporation shall be 18117 Regents Square Drive, Tampa, Florida, 33647.

<u>ARTICLE III - DURATION</u>

The existence of this corporation shall commence on filing of these Articles of Incorporation by the Department of State, and the period of its duration and existence shall thereafter be perpetual.

ARTICLE IV - BUSINESS, PURPOSE AND POWERS

The general nature of the business to be transacted by this corporation, or the objects or purposes of the corporation, shall be as follows:

to engage in, conduct and carry on the business of consulting and support services for recreational activities, and related services, including, but not limited to, the promotion and instruction of hockey in the general community, and to engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith; and

<u>ARTICLE V - CAPITAL STOCK</u>

ARTICLE VII - BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of not less than one (1) nor more than six (6) members (directors), the exact number of directors to be fixed from time to time by the stockholders or the Bylaws.
