The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the state of Florida.

ARTICLE 1 - NAME

The name of this Corporation is STEEL TECHNOLOGY, INC.

ARTICLE 2 - DURATION

This Corporation is to exist perpetually.

ARTICLE 3 - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawfull business including but not limited to every aspect of building homes.
