

**ARTICLES OF INCORPORATION
OF
QUALITY TANK TRUCK AND EQUIPMENT SALES OF FLORIDA, INC.**

These Articles of Incorporation (the "Articles") are hereby executed this 3 day of March, 1999, by the undersigned incorporator (the "Incorporator"), who submits these Articles for the purpose of forming a corporation (the "Corporation"), which shall engage in the lawful conduct of business both within and without the State of Florida, and who hereby declares and certifies that the statements contained herein are true and correct.

1. Name. The name of the Corporation shall be, "QUALITY TANK TRUCK AND EQUIPMENT SALES OF FLORIDA, INC."
2. Initial Street Address. The initial street address of the principal office of the Corporation shall be 8892 Normandy Boulevard, Suite A-1, Jacksonville, Florida 32221.
3. Initial Mailing Address. The initial mailing address of the Corporation shall be the same as the initial street address.
4. Authorized Shares. The Corporation shall have a maximum Ten Thousand (10,000) authorized shares, with each share having a par value of One Dollar (\$1.00).


