The name of the corporation is 5600 N.E. MINI PLAZA, INC. and the address and mailing address of the principal office is at 1655 N.E. 115th Street, Miami, Florida 33181.

ARTICLE II

This corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE III

This corporation is organized for the transaction of any and all lawful business as may be permitted by law.
