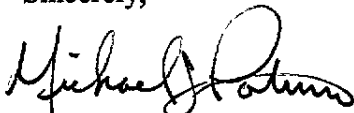

**FIRST:** Amendment adopted:

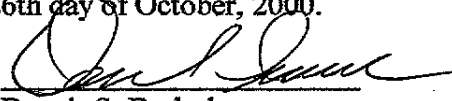
Article 1 of the Articles of Incorporation of this corporation is being amended to rename the corporation to NEURON Broadcasting, Inc.

**FOURTH.** This Amendment was adopted by the board of directors and by a majority of shareholder approval.

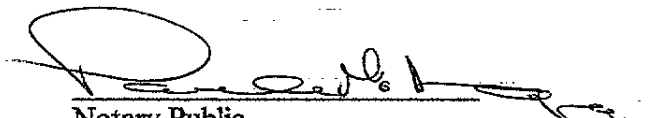

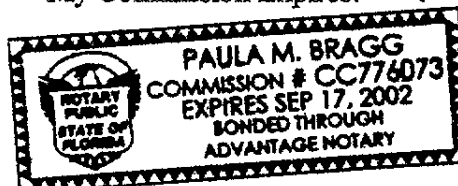
