As per my telephone on December 11, 2001 with Michelle (examiner), I understand the urgency of this matter regarding reinstatement fees stated on the December 3, 2001, letter address to LONGEV ENTERTAINMENT, INC. Unable to respond last week, due to the unprofessional typing service experience and upon receiving our computer back from service today, I'm expediting this letter in correspondence. The facts and reasons stated below are why we are seeking for the reinstatement fees to be waived.

*ON APRIL 17, 2001; I called Division of Corporations and order Uniform Business Report to file before deadline. Copy Enclosed.

*ON APRIL 30, 2001; Mailed Uniform Business Report and filing fee with additional monies for certificate. PAID \$158.75 mailed out priority mail. Copy Enclosed.

*ON JUNE 11, 2001; I placed a follow-up call to Division of Corporations to inquire about the status of certificate I had not received. Examiner, explains there is no record of filing so she fax a copy of the Uniform Business Report to (407) 854-7829, but I would have to mail Uniform Business Report to be filed and then certificate would be forward. Plus, I informed examiner of change of address from 5594 N. ORANGE BLOSSOM TRAIL, PMB # 107, ORLANDO, FL. 32810-1040 to 5077 PARK CENTRAL DR. # 1525, ORLANDO, FL. 32839.

*ON JULY 25, 2001: As follow up call to status of certificate sent to new place of business, examiner informs me again that no record of Uniform Business Report was filed under new address and since I did not have another Uniform Business Report that I should go on-line an make a copy and mail that Uniform Business Report to Division of Corporations. I complied and sent the Uniform Business Report first class mail.

*ON SEPTEMBER 18, 2001; My follow up call revealed per examiner that Uniform Business Report was received but not filed because all officers must be listed and must have director (s) signature. Process must be completed in this last quarter of the year. I informed the examiner that I was out of town fulfilling contract obligations and that I would forward all necessary documents by Mid-November when I return.

*ON NOVEMBER 14, 2001. I MAILED the Uniform Business Report to Division of Corporations, Enclosed are copies of those documents plus your response on in the beginning of December.

We are a very small company with very limited budget and can not afford to pay the request reinstatement fee, so please accept this letter with understanding and patience in re-evaluating this case. Also, please consider as a factor the past, recent and current problems with in the postal service. I'm humbly asking for the reinstatement fee to be waived.
