ARTICLES OF INCORPORATION

OF

FLORIDA COAST SURVEYING, INC.

The undersigned incorporator hereby forms a corporation pursuant to the Florida Business Corporation Act, Chapter 607 of the laws of the State of Florida and adopts the following Articles of Incorporation.

ARTICLE I -- NAME

The name of the corporation shall be: **Florida Coast Surveying, Inc.**

The initial address of the principal office and place of business of this corporation shall be 2411 22nd Avenue West, Bradenton, Florida 34205, and the mailing address of the corporation shall be the same. The principal address and mailing address may change from time to time.

ARTICLE II -- NATURE OF BUSINESS

This corporation may engage or transact in any of all lawful activities or business permitted pursuant to the laws of the United States of America, the State of Florida or any other state, country, territory or nation. Initially, the corporation intends to perform surveying and mapping services, but is not limited to that business.

ARTICLE III -- CAPITAL STOCK

The maximum number of shares of stock that this corporation

is authorized to have outstanding at any one time is 7,500 shares of common stock having \$1.00 par value per share.

ARTICLE IV -- REGISTERED AGENT

The street address of the initial registered office of the corporation shall be 856 2nd Avenue North, St. Petersburg, Florida 33701, and the name of the initial registered agent of the corporation at that address is John P. Cullem, Esquire.

ARTICLE V -- TERM OF EXISTENCE

This corporation is to exist perpetually commencing five days prior to the date of receipt and filing of these Articles of Incorporation.

ARTICLE VI -- DIRECTORS

All corporate powers shall be exercised by or under the authority of, and business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. 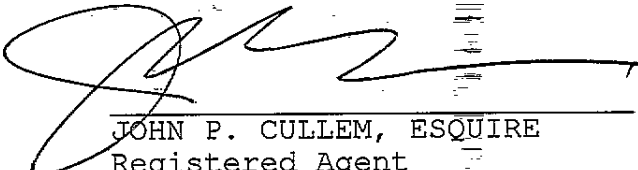
