THE PERIOD ,TERM AND DURATION IS **PEREPUALITY**

ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS BUSINESS AS A FULL SERVICE AUTO REPAIR AND AUTO BODY SHOP , WHEREIN, WE WILL PROVIDE AUTO REPAIR & AUTO BODY WORK TO VIRTUALLY ALL DOMESTIS AND FOREIGN CARS. 


