ARTICLES OF INCORPORATION

IN ORDER to form a corporation under and in accordance with the provisions of the laws of the State of Florida for the formation of corporations for profit, the undersigned, hereby forms a corporation for the purpose and with the powers hereinafter mentioned; and to that end I do, by this Certificate of Incorporation, set forth:

I.

The name of the corporation is: ELKIN TITLE SERVICES, INC.

II.

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

III.

The total number of shares of stock which this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of stock at \$0.01 par value.

IV.

The amount of capital with which the corporation will begin business shall not be less than Five Hundred (\$500.00) Dollars.

V.

The corporation shall have perpetual existence.

VI.

The principal office of the corporation shall be located at:

but the corporation may maintain offices and transact business in
such other places within or without the State of Florida as may
from time to time be designated by the Board of Directors.

VII.

VIII.

The names and street addresses of the first Board of

Incorporation, the By-Laws, and the laws of the State of Florida,
shall hold office for the first year of the corporation's
existence, or until their successors are elected and have
qualified, are: BARRY M. ELKIN

IX.

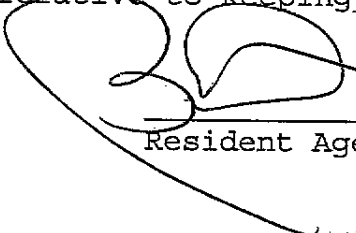
