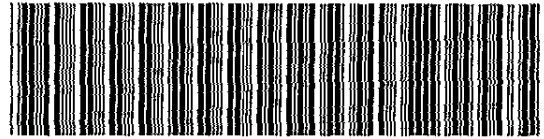

The name of the corporation is EXCLUSIVE TITLE SERVICES, INC.




**DATE AND MANNER OF DISSOLUTION**
