**ARTICLE I - NAME**

The name of the corporation is:

DAVID R. SPITZNAGEL, P.A.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607 and Chapter 621, Florida Statutes, as now exists or may after be amended. The specific nature of the professional association is the general practice of law in the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 1,000 shares of common stock, having a \$1.00 par value. 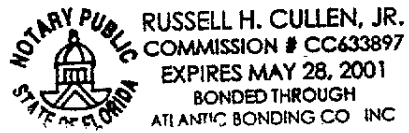


