ARTICLES OF INCORPORATION OF:

EL BUEN AMIGO RESTAURANT, INC. 6906 West 29th Avenue Hialeah Florida 33016

ARTICLE I - NAME

The name of this corporation is: EL BUEN AMIGO RESTAURANT, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE
