The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

<u>FIRST</u>: The corporate name for the corporation (hereinafter called the "corporation") is WORLD WIDE EVENTS, INC.

SECOND: The street address, wherever located, of the principal office of the corporation is 2328 23rd Court, Jupiter, FL 33477.

THIRD: The number of shares that the corporation is authorized to issue is 200 (Two Hundred), all of which are without par value and are of the same class and are Common shares.
